state the following: I'm currently enrolled as a full time student at Iona University. On 10/17/10 I went to the Pace University to visit friends. I met up with my friends, Dwayne Jones, Mr. Seaford, "DP", and Joey Garcia at New Dorm. I arrived there at approximately 10:45pm - 10:50pm. Approximately 1/2 hour later we left to meet other friends at Finnegan's Grill in Thornwood, NY. I drove my car, a 1998 white Lexus with Dwayne Jones as a passenger. Mr. Seaford (unknown first name) drove his own car. We arrived at the bar at approximately 11:30ish. We waited outside the bar for maybe three or four minutes because it was crowded inside and we waited for some people to leave. The owner/manager was outside and there was a bouncer at the door checking IDs. When we got inside we met up with friends, Brandon Cox, Desmond Hinds "Dez", Danroy Henry "DJ", "Yeves", and "DP". While inside, we were hanging out near where the DJ was set up. At one point there was a little fight between two girls which was quickly broken up. A little while later we heard an incident occur by the door. These kids were separated and I heard someone say it was a guy fighting with the bouncer. We couldn't see because the lights were low and there were kids standing on the chairs blocking our view. Approximately 15-20 minutes later the lights came on and we had to leave. We had been in the bar approximately 2 - 2 1/2 hours when the lights came on. There were approximately 100-120 students all heading towards the exit door. We decided we were going to go to an after hour party at the Townhouses #32. As we were heading out the door, DJ, Brandon and Dez were up front and I was stuck in the back with Dwayne and Seafe. I yelled to DJ and Dez because I didn't know the directions to the Townhouses and they didn't hear me however Seafe grabbed me and said I could follow him. When we finally made it to the front door, I stepped outside with DP and it was kind of cold. We waited a few minutes for the rest of the guys coming behind us. I went back in to get them maybe twice and as I was standing outside with DP I then heard two shots; Bang Bang. I turned to DP and asked who had fireworks. People were starting to run towards us and a girl screamed. She came running toward us stating they're shooting. There was a two or three second pause and then we heard approximately six shots one right after the other. DP and I moved toward the shooting and out into the street to get a better view. The

owner came running up yelling for everyone to get back inside the bar. DP then noticed that the car stopped on the roadway was DJ's and he told me that was DJ's car. We moved forward more and I saw that both the front driver's side and passenger's side doors were open. There was a Police Officer in front of DJ's car handcuffing Brandon and putting him on the ground. As we ran up to the car I then noticed that Dez was lying on the ground handcuffed. I asked him if he was all right and he didn't respond. I looked into the car to see if anyone was inside and I didn't see anyone. A Police Officer then comes from the front of the car with his gun drawn and he points it at me telling me to get back. We (approximately 15-20 kids) all moved up onto the sidewalk area and a girl passes out next to me. I went around a cement pillar to get a better view and was met by a second officer in a yellow vest type shirt, with a taser gun who told us to backup. Brandon was yelling that he was shot. I moved towards the back of DJ's car and I see a Police Officer on one knee with a flight suit type outfit on. He was just looking at the ground. As we moved toward the driver's side I was able to see only the upper torso part of DJ as he was face down handcuffed on the ground. He appeared to be shaking a bit. An unknown Police Officer then comes up to DJ approximately five to seven minutes later. He rolls DJ onto his side and then it appears he uncuffs him and lays him on his back. At this time I could see that DJ was in real bad condition. I then just lost it. Dwayne Jones came up behind me and grabs me pulling me back. Numerous Police Officers were now arriving. Police were chasing kids all over the parking lot for whatever reason I don't know. Dwayne pulls me over to the CVS so I don't get into trouble. I was yelling, cursing, screaming and just upset. At this time I see an ambulance arrive and pull in front of DJ's car. They put someone inside on the stretcher but I know it wasn't DJ as they were white. The first ambulance leaves and approximately five minutes later a second ambulance arrives and pulls into the same area. They remove an unknown person (possibly DJ) and then leave. I don't know what happened to Brandon or Dez. I lost track of DP. We then left and started walking towards the gas station. We saw Seaford across the street in the parking lot and he said we couldn't get our cars out of the lot as they were taped inside the scene by Police. When we walked to the gas station we met a White female and Black male who offered us a ride back to Pace where they dropped us off at the New Dorm in Joey Garcia's room. Dwayne went back out with this couple as they offered to give more students rides back to campus. Dwayne had me cell phone at this point and it was just me and Seaford in the room. 36
