DET MENDOZA REPORTING: 10/17/2010 APPROXIMATELY 0150 HRS RECEIVED A CALL ON MY CELL PHONE FROM PO VALENTNO WHO ADVISED DETECTIVES WERE NEEDED REGARDING A SHOOTING AT FINNEGAN'S. I IMMEDIATELY RESPONDED TO MPPD TO RETRIEVE EQUIPMENT AND MY POLICE VEHICLE. APPROXIMATELY 0205 HRS ARRIVED ON SCENE AND PARKED MY POLICE VEHICLE IN AREA OF CVS PHARMACY. I THEN MADE CONTACT WITH SGT ROMAINE AND LT MILIAMBRO WHO WERE ATTEMPTING TO EVALUATE THE SCENE. I WAS THEN ADVISED BY UNKNOWN OFFICER THAT PLEASANTVILLE PD PO AARON HESS'S K-9 WAS STILL INSIDE HIS VEHICLE. I MADE ARRANGEMENTS WITH MTA K9 OFFICER TO HAVE THE K-9 REMOVED TO WESTCHESTER COUNTY PD KENNEL AS PO HESS'S PATROL VEHICLE WAS PART OF THE SCENE AND COULD NOT LEAVE THE AREA. I WAS THEN ADVISED BY PLEASANTVILLE PD LT. RICH LOVE THAT PPD PO KEVIN GILMARTIN WHO WAS STANDING BY A PATROL UNIT WAS IN POSSESSION OF PO HESS' S SERVICE WEAPON. I RETURNED TO MY POLICE VEHICLE WHERE I RETRIEVED A PAPER EVIDENCE BAG, RETURNED TO PO GILMARTIN'S LOCATION AND HAD HIM PLACE A GLOCK PISTIOL, MAGAZINE AND EJECTED ROUND INSIDE THE LARGE PAPER BAG. I THEN IMMEDIATELY SECURED HESS'S WEAPON IN THE LOCKED TRUNK OF MY POLICE VEHICLE. I WALKED TOWARDS WHERE MPPD OFFICERS SGT ROMAINE, LT MILIAMBRO AND LT FANELLI WERE GATHERED. LT FANELLI ADVISED ME TO TAKE SEVERAL WITNESSES WHO WERE IN THE AREA INTO MPPD FOR INTERVIEWS. I HAD 3 MALE SUBJECTS LATER IDENTIFIED AS ALI MOURTADA, JAMES LYNCH AND ESHAWN ARMSTRONG FOLLOW ME TO MY POLICE VEHICLE. UPON ARRIVAL AT MPPD MOURTADA WAS ESCORTED TO MPPD INTERVIEW ROOM WHILE LYNCH WAS ADVISED TO WAIT IN THE HALLWAY. ARMSTRONG WAS ESCORTED TO THE DETECTIVES INTERVIEW ROOM WHERE HE SAT DOWN. I QUICKLY BRIEFED DET BROWN REGARDING INCIDENT. I THEN SECURED PPD OFFICER AARON HESS'S SERVICE WEAPON IN PROPERTY LOCKER NUMBER 1.
