I, ALI MOURTADA AGE 20, DO GIVE THIS TRUE AND VOLUNTARY STATEMENT TO DET GREENBERG OF THE MT PLEASANT POLICE DEPARTMENT.

I AM A JUNIOR AT PACE UNIVERSITY, CURRENTLY LIVING IN DOW HALL, BRIARCLIFF CAMPUS, ROOM 320. I AM A KICKER ON THE PACE FOOTBALL TEAM. AROUND 5:30PM I STARTED DRINKING SOME YAEGER BACK AT MY DORM WITH SOME FRIENDS. I WENT OVER TO THE TOWNHOUSES AROUND 7:30PM WITH SOME FRIENDS FROM THE FOOTBALL TEAM AND WE PARTIED UNTIL ABOUT 10:30. MY FRIEND DJ (DANROY HENRY) WAS THERE TOO, HE WAS WITH A KID FROM THE STONE HILL TEAM WE PLAYED TODAY THAT HE KNEW FROM HIS HOME TOWN. I KNEW THE KID TOO FROM MY SENIOR YEAR. AROUND 11:00PM WE HEADED UP TO FINNEGANS, I GOT INTO THE BAR AROUND 11:40PM. THE BAR WAS THE SAME OLD, BIG CROWD, TOUGH TO GET A DRINK BECAUSE OF THE CROWD AT THE BAR. DANCE FLOOR WAS PRETTY GOOD. AT ONE POINT THE MUSIC STOPPED, AND THE LIGHT CAME ON. I HEARD SOMEONE THAT WORKS THERE SAY TO EVERYONE TO GET OUT. I WENT OUT ON MY OWN AND TRIED TO FIGURE OUT WHERE MY FRIENDS WERE. I SAT ON A BENCH NEAR SOME ELEVATED PLANTS ABOUT TEN FEET FROM FINNEGANS. WHERE I WAS SITTING, FINNEGANS WAS TO MY LEFT, AND THE CORNER STORES WERE IN FRONT OF ME. MY BACK WAS TO CITIBANK. I GOT UP AND WALKED TO MY RIGHT ON THE SIDEWALK. DJ WAS PARKED IN HIS NISSAN BY THE SIDEWALK WHERE I WAS AND I SAW A COP COME UP BEHIND HIM. THE COP GOT OUT OF HIS CAR AND WALKED UP TO THE DRIVER'S SIDE OF DJ'S CAR. I WAS STANDING OUTSIDE THE PASSENGER SIDE. THIS KID BRANDON WAS DJ'S FRONT SEAT PASSENGER. I KNOCKED ON THE PASSENGER SIDE WINDOW AND SAID YO THERE IS A COP RIGHT THERE. I DON'T KNOW IF HE SAW THE COP. DJ PULLED AROUND THE CURVE TOWARDS FINNEGANS AND CITIBANK AND WHILE HE WAS PULLING OUT THE COP CARS WERE ALL LINED UP TO THE LEFT FACING DJ. WHEN HE PULLED AWAY THE COP BY ME WAS SIGNALING WITH HIS HAND TO THE OTHER COPS TO STOP DJ. ONCE DJ PULLED THE CORNER, ANOTHER COP WAS BY HIS CAR AND WENT OUT IN THE ROAD TO STOP DJ. DJ HIT THE COP WITH HIS CAR AND THE COP WAS ON THE HOOD - IT TOOK OUT THE COP'S LEGS AND HE FELL RIGHT ON TOP OF THE HOOD AND I SAW HIM FIRE TWO SHOTS AND I SAW THE GUNSMOKE AND I THOUGHT DJ KEPT GOING, BUT AFTER I SAW THE CAR HAD STOPPED.
