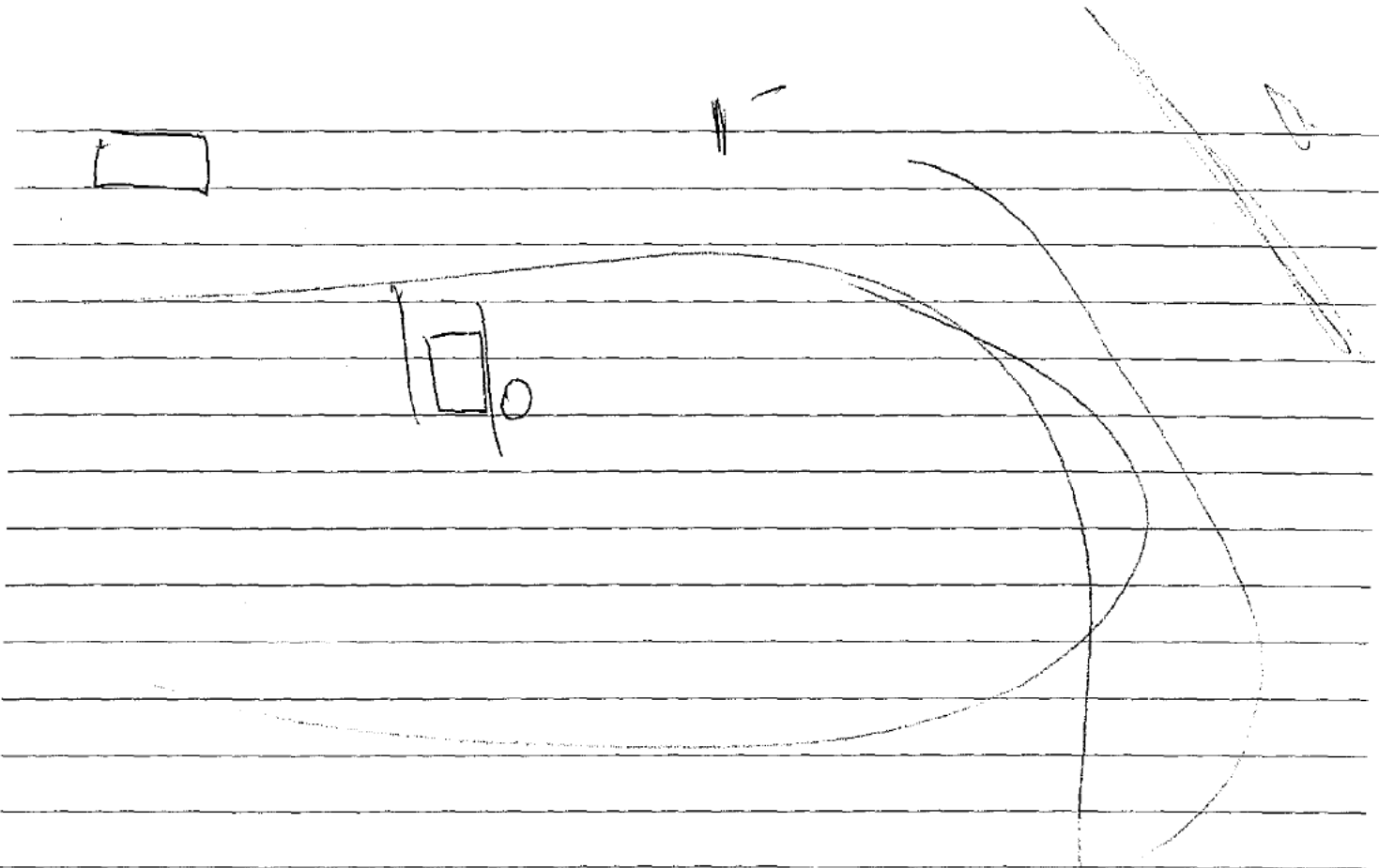

I KEVIN SCOTT DOB 09/20/1990 RESIDENT OF 686 3RD PLACE SOUTH GARDEN CITY NY 11530 PROVIDE THIS TRUE AND VOLUNTARY STATEMENT TO DETECTIVE MENDOZA OF THE MT PLEASANT POLICE DEPARTMENT ON 10/17/2010 AT 0345 HRS.
ON SATURDAY 10/16/2010 I WENT TO VISIT A FRIEND OF MINE JOE FASANO WHO PLAYS FOOTBALL FOR PACE UNIVERSITY. AFTER THE GAME WE HUNG OUT AT HIS DORM AND THEN ABOUT 11:00 PM WE WENT TO FINNEGANS BAR. A FEW HOURS LATER THE LIGHTS WENT ON INSIDE FINNEGANS AND EVERYONE STARTED TO LEAVE. AS I WAS STANDING IN THE PARKING LOT GETTING READY TO ENTER MY FRIEND JOE FRIEND'S CAR I HEARD A CAR SPEEDING IN THE PARKING LOT NEAR THE FRONT OF FINNEGAN'S.
