I PETER VITELLI DOB [REDACTED], MT VERNON POLICE OFFICER FOR THE PAST YEAR INN A HALF, PROVIDE THIS TRUE AND VOLUNTARY STATEMENT TO DETECTIVE MENDOZA OF THE MT PLEASANT POLICE DEPARTMENT ON 10/17/2010 7:10 AM.

ON SATURDAY 10/16/2010 MY FRIENDS CONVINCED ME TO GO OUT TO FINNEGAN' S BAR. I MET JORDAN ROSSI AND PAUL DOHERTY AT FINNEGANS IT WAS ABOUT 12:45 AM. I JUST WENT INSIDE WHEN THERE WAS A PROBLEM BETWEEN TALL WHITE MALE AND THE BAR BOUNCER. THE BAR WAS CLEARED OUT. I THEN STOOD OUTSIDE BY THE MAIN RD IN THE AREA OF THE BAGEL STORE WHEN I SAW COP CARS COME INTO THE TOWN CENTER. THE FIRST OFFICER I SAW WAS AARON HESS A PLEASANTVILLE POLICE OFFICER I KNOW FROM GROWING UP IN PLEASANTVILLE. AARON PARKED HIS POLICE CAR IN THE ROAD COMING IN NEAR CITI BANK. AARON FIRST GOT OUT AND SPOKE WITH PEOPLE PARKED IN A CAR IN THE FIRE LANE. I THEN SAW A MT PLEASANT POLICE OFFICER PULL BEHIND A NISSAN ALTIMA WHICH WAS PARKED IN THE FIRE LANE BETWEEN DRESS BARN AND THE LIQUOR STORE. I SAW THE MT PLEASANT OFFICER WALK TOWARDS THE DRIVERS SIDE OF THE ALTIMA AND BANG ON THE REAR WINDOW ON THE DRIVERS SIDE WITH HIS FLASHLIGHT. THE MT PLEASANT OFFICER THEN TAPPED ON THE FRONT WINDOW AND THE DRIVER'S WINDOW CAME DOWN ABOUT A QUARTER OF THE WAY. I THEN SAW THE WINDOW GO BACK UP AND THE ALTIMA PULL AWAY. IT APPEARED THE MT PLEASANT OFFICER HAD HIS BODY PRESSED AGAINST THE DRIVER'S DOOR AS THE ALTIMA PULLED AWAY. I SAW THE MT PLEASANT OFFICER WAVING HIS HAND. I THEN SAW OFFICER AARON HESS STEP OUT IN THE ROAD AND PUT HIS LEFT HAND UP AND HIS RIGHT HAND ON HIS GUN AS THE ALTIMA WAS COMING TOWARDS HIM. I ALSO HEARD OFFICER HESS YELL AT LEAST THREE TIMES FOR HE CAR TO STOP. I THEN HEARD THE ALTIMA ACCELERATING AS IT APPROACHED OFFICER HESS. THERE IS NO WAY THE DRIVER DID NOT SEE OFFICER HESS. I THEN SAW THE FRONT DRIVER SIDE OF THE ALTIMA STRIKE OFFICER HESS AT WHICH TIME OFFICER HESS FELL ONTO THE HOOD OF THE ALTIMA AS THE ALTIMA KEPT DRIVING TOWARDS THE EXIT. I THEN HEARD SOME SHOTS BUT I DO NOT KNOW HOW MANY. I THEN SAW THE ALTIMA GO TO THE LEFT AND STRIKE THE ROW OF POLICE CARS WHICH WERE PARKED ON THE ROAD COMING INTO THE SHOPPING CENTER. I SAW THE ALTIMA ROLL TO A STOP AND OFFICER HESS FALL OFF THE FRONT OF THE ALTIMA. I THEN SAW THE FRONT SEAT PASSENGER EXIT THE ALTIMA AND BEGIN T RUN TOWARDS FINNEGANS. A MT PLEASANT OFFICER GRABBED THE PASSENGER PUT HIM ON THE GROUND. I THEN SAW ALL OTHER COPS COME TO THE SCENE.

I AM AT THE MOUNT PLEASANT POLICE DEPARTMENT WHERE I AM GIVING THIS STATEMENT TO DET MARCO A. MENDOZA WHO IS TYPING IT FOR ME, AND I HAVE READ IT AND IT IS THE TRUTH.
